Skagit Valley and River Field Trip Report January 2020

Sometimes, Mother Nature steps in and disrupts the best laid plans for a winter field trip. The weather reports for the days leading up to the weekend field trip were downright miserable. It was raining nonstop and the forecasts called for cold and wet snow for the entire weekend. On top of that, club members were letting me know that they were forced to cancel their seats on the photography jet sled due to illness. I found myself scrambling to try to get other members on the boat but there were no takers. I couldn't blame them.

Greg and I decided that we would still go because it was too late to get refunds and because I was the "field trip



leader." On Saturday morning, we reluctantly made the drive up north. We spent the day in the Skagit Valley watching soggy trumpeter swans standing in the fields. But we also discovered a few places we had never visited and enjoyed the parts of the day when the sun peeked through.

Later that day, we made our way up along the Skagit River to Rockport where the pho-

tography jet sled would launch the next morning. It was still raining and then the snow started falling. That evening, we ventured out from our cabin to the restaurant where I had told everyone we would meet for dinner. To

my horror, the restaurant was dark, i.e., closed. I had contacted the restaurant several weeks before to confirm they would be open on that night and was assured that they would be there for us. By then, I



was sure that no one would ever want me as an OCC field trip leader ever again. The thing was, though, that no one from the club showed up for dinner, something that made me laugh out loud – partly out of relief. The club members all knew better than to spend a weekend traipsing around in the muck trying to photograph wet birds.

The next morning, Greg and I headed to the boat launch in our winter and rain gear. I'm sure we looked like we (Continued from page 4)

were headed to Antarctica. For about the first 45 minutes

of the trip, I had trouble focusing on eagles because of the rain and snow. And I didn't dare try to point my long lens up toward the birds in flight or in the trees for fear of getting my lens soaking wet. It



got so cold and wet that my right thumb started to swell, making it hard to press the AF On button (I use back button focus).

But then, the weather started to clear up (still cold though) and the light became amazing. There were lots



of eagles everywhere and we got to practice tracking birds in flight from different directions. The rest of the boat ride was truly fantastic – perfect light and beautiful birds.

We ended up staying on the river for 3-1/2 hours and I came home with some of my best photos ever of eagles in flight. And the swelling in my thumb subsided on the car ride home.



Ridgefield National Wildlife Refuge Saturday, February 22, 2020 11:00am – 5:00pm

The Refuge provides shelter for waterfowl, shorebirds, raptors, river otter, black-tailed deer, coyotes, and other species of wildlife. Between October 1 and April 30, all visitors must remain in their vehicles while traveling the Auto Tour Route. The animals in the Refuge are accustomed to seeing cars and will allow vehicles to pass by, or even stop, within a few feet without taking flight. Your car is your personal blind on wheels. Please stay in your car. During this time of year, you may exit your vehicle only at the Refuge entrance parking lot and to use the observation blind located midway along the tour route. Also, use turnouts to stop and observe wildlife or pull over to the side as much as you can to allow other vehicles to pass.

The field trip will be along the 4.2-mile auto tour route. The Refuge includes another section that will not be part



of this field trip. At the end of this article is a link to the complete map of the Refuge just in case you want to visit it on another visit. Be aware that if you drive down using your own your GPS system it

may try to take you to the other section of the Refuge. You will be going the right way if you take exit 14, turn right onto Pioneer St, and then take a left at the stop sign on to S 9th Ave which will become S. Hillhurst Rd. The Refuge will be on your right in about a half mile.

The leader of the field trip will meet up with members at the visitor info booth within the Refuge at 11am. The

Refuge opens earlier for those who want to go down bright and early, but the marshy area is known be socked in with fog during the winter months in the morning. There is a fee to enter the park of \$3 per car, cash or check. It is free for those who have a Federal Interagency Senior Pass. Please bring exact



amount if you plan to pay with cash. You will need to pack any food and/or drink you want. There are pit toilets but no trash cans. Pack out what you bring in. You will be shooting from your car so you should bring a long lens and a towel or small pillow to brace your lens on

when taking photos. It is suggested that there be only two people per car, the driver and one person in the back seat.

If you would like to carpool and don't know anyone else who is going, please email the field trip leader Tammy and she will try to get you joined up with someone.

Get ready for a wonderful 2020 with the Olympia Camera Club. Pay your dues and put Saturday, March 28, on your calendar. OCC will have a field trip to Wolf Haven. Club members will be able to see Grey wolves, Mexican Grey wolves, Red wolves and coyotes. This is a private sanctuary visit so it will be available just for ac-

tive Club members and limited to only the first twenty people. We will allow signups past the first twenty in case someone can't make the field trip. Chuck Paeth (Club member) will be the guide, providing the story of each wolf and will answer questions. The cost is \$9/ senior (62+), \$11/adult. Please bring the exact amount in cash. There will be a signup sheet at the next few meetings. The signup sheet will have a place to note if you would like to carpool. We will try to connect those who want to carpool with others.

The sanctuary visit will begin at 10 am. Club members should plan to arrive no later than 9:45 am. The visit will last about 50 minutes. There is plenty of parking at Wolf

Haven. We will meet outside of the gift shop. Wolf Haven is located at 3111 Offut Lake Rd. SE Tenino, WA. Club members can get more information by

The wolves are located in 1/3 acre enclosures. The enclosures are constructed of chain link fencing. We will be anywhere from 20-50 feet from the wolves. Most of the wolves are interested in visitors so they will likely be at the front of the enclosures. There are trees in the enclosures so there can be heavy shade. Photo opportunities will include wolves, coyotes, eagles, ravens and a very interesting fir tree (the Grandfather Tree). Club members are free to photograph anything at Wolf Haven. 


OCC Publishing Party

KENMORE CAMERA PHOTO GALLERY

The Northwest Council of Camera Clubs has an opportunity to be represented in a **PHOTO GALLERY** at the Kenmore Camera Store. The show will be in September and October of 2020. Note the deadlines for clubs to **RSVP** is by April 1, 2020 and deliver photos by July 15, 2020 to put this together. Here are the details:

Deadline for RSVP to participate is March 27. Please advise either Bruce Livingston or Frank Townsend by the end of the March 27 membership meeting if you want to participate. After this date we will determine if OCC will submit a print or not. We will advise NWCCC on April 1 of our decision.

Each club is asked to submit (1) photo and have in reserve (1) other photo if needed. The gallery holds up to 22 photos, so if any club does not RSVP in April, some clubs may be asked to submit two. You can choose your photos using any criteria your club decides. In April NWCCC will contact you if there is an opportunity to submit a second photo.

Theme: The store owner is requesting original photos of the Pacific Northwest that are landscapes, wildlife, sports, scenic, or shapes and/or patterns found in nature. No "Altered Reality" or "Creative" images that have been created or heavily manipulated in a computer. No nudes.

Orientation: A portrait or landscape orientation is fine.

Each club or photographer is responsible for the costs of matting and framing the photo(s). Mats must be WHITE (any shade) and frames must be BLACK. No brown wood grain, gold, silver, or any other color than black frames.

Size – no smaller than 12 x18 or larger than 20x24. This measurement is the INSIDE of the frame, i.e. the outside edge of the mat. Rectangles and squares are fine.

Wired – the frame must be wired on the back. Images that are not framed or wired correctly will not be in the gallery.

Sales: Each photo needs the following information. Title, Maker's name, Club Name, photographer's email, phone and (optional) price. Prospective buyers will need to contact the maker directly. Kenmore Camera will not facilitate any sales.

Deadline to submit framed photos: July 15, 2020. Photos can be brought to a NWCCC

Board meeting (on May 9 or July 11) or delivered to Frank Townsend, call (360)705-1349 to arrange a delivery. Please deliver photo labeled in the upper right corner with Title, Name of Maker, Club name, maker's email and phone number and (optional) price. 

Pam Hoaglund has submitted the February PSA Interclub digital images. Pam led a discussion on members getting their images in on time.


New Business


